**164.14 DECLARATIONS OF INTEREST**

**165.14 EDDC COMMUNITY GOVERNANCE REVIEW DRAFT RECOMMENDATIONS**

The draft recommendations proposed by EDDC were discussed.

It was AGREED that Cllrs Davies, Dover, Johnson, Mitchell, Packer, Smith and Roberts would form a working party to co-ordinate the Council's plans to inform residents and also respond to EDDC's recommendations.

**166.14 MEETING WITH BLOOR HOMES**

EDDC had advised that the £30,000 Section 106 money would be allocated to the Colehill and Wimborne Youth and Community Centre. The Council agreed with this decision, but had been under the impression that there could be more money available for other community projects.

It was therefore AGREED to send the following wish list to EDDC should further money become available:

- (a) Replacement flat roof for Colehill Community Library
- (b) Commercial kitchen for Colehill Memorial Hall
- (c) Seesaw at Oliver's Park
- (d) Refurbishment of the toilet block at the Scout and Guide hut at Oliver's Park
- (e) A community bus service.
