The Planning Case Officer was in negotiation with the applicant regarding his application to vary Condition 5 which governed the number of burials per week and hours when burials might take place.

No objection would be raised to some variation in the number of burials per week provided they took place on weekdays, and within the time-frame approved by DCC Highways with regard to traffic flow on approach roads.

120.05 PARISH PLAN FOR COLEHILL

MINUTE 87.05

Further to the comments made under 'Public Participation', Members recalled that in 2004 the Council had debated the matter but decided against the preparation of a Parish Plan at that time. (Minute 60.05 refers). The degree of public interest aroused by the recent planning application to develop the old site of Colehill First School, had caused some Members to reconsider the desirability of having a Community Plan to serve as a point of reference when major community issues arose.

Following a lengthy discussion it was RESOLVED that the matter be deferred until the next meeting (27 September) to allow further information to be obtained together with examples of Plans prepared by other Local Councils in East Dorset of comparable size to Colehill.
