7. Furzehill Woodland known as Woodleaze Copse (*Minute No refers 408.16 - Recreational Green Space*)

The Furzehill Residents' Association (FRA) wishes to safeguard the woodland at Furzehill (known as Woodleaze copse and outlined in red on the attached map). There are no tree preservation orders on this land.

EDDC has informed the FRA that it has not yet taken a decision on whether to place the land at Furzehill on the open market. If EDDC does decide to market the land, marketing agents will be appointed to advise them on the most appropriate method to achieve best value from the council's asset. Options such as dealing with Woodleaze copse as a separate transaction may be considered, but EDDC is not in a position to advise whether this will be included as an option in the marketing material.

The FRA wishes to preserve Woodleaze copse and ensure that any proposed development does not impact on the wooded area.

Cllr Packer to lead on this item and the Parish Council to consider what assistance could be offered to ensure that the copse is preserved.
