278.16 DECLARATIONS OF INTEREST

There were no declarations of interest.

279.16 CHAIRMAN'S REMARKS

The Chairman advised that she had attended the switching on of the Christmas tree lights at Colehill Community Library and that she had switched on the Christmas tree lights at St Michael's Church. The Chairman said that the members of the library had asked her whether any thought had been given to changing the location of the community Christmas tree. The Clerk advised that the Christmas tree would be reviewed at the January Council meeting.

The Chairman also advised that she had enjoyed her Reception and that a review of the Reception would be held later in the meeting.

Finally, the Chairman read out a letter she had received from Michael Tomlinson MP regarding the local government finance settlement consultation.

280.16 PLANNING APPLICATION - 3/16/2321/FUL 66 HAYES LANE

Members considered the planning application to erect three 3 bedroom bungalows, one 4 bedroom chalet bungalow and one 4 bedroom house following the demolition of the existing dwelling and commented as follows:

The Council considers that this development is an overdevelopment and out of keeping with the area. The Council also considers that any house built on this site will have a detrimental affect on the neighbouring properties. The Council is also concerned about any damage that may occur to the existing trees. If the Council's objection comment is at variance to the Planning Officer's then the Council would like the PA to go to EDDC Planning Committee to enable the neighbours to speak of their objections.

281.16 REVIEW OF RECEPTION 2016

Members reviewed the Reception and considered that the evening had gone well. The extra tables and chairs seemed to be appreciated although some Members thought that this deterred people from mixing. It was suggested that other venues should be considered on a rota basis so that all Colehill venues were showcased. The venue for the Reception on 17 November 2017 would be considered at the January Council meeting.

287.16 **REPORTS**

- (a) Cllr King reported that the Trustees of the Colehill and Wimborne Youth and Community Centre were arranging for sound proofing work on the building at a cost of £4,000. He also advised that he would be raising constitutional issues at the AGM.
- (b) Cllr Dickins reported that the Colehill Management Memorial Hall had discussed the Council's request for Wi-Fi, but had decided not to install it. The Hall's decision would be discussed at Finance and General Purposes committee.
- (c) Cllr Warren reported on the meeting that he and Cllr Holloway had attended at Bournemouth Airport. The meeting had been well attended. One of the main areas of information was that the airport was being used by up to 91% capacity whereas most airports only managed 70-75%.

(d) Cllr Roberts had inspected St Michael's Dirt and was concerned about one of the jumps and the landing, which he considered needed widening. The Clerk would put him in contact with the lead rider.
