87.18 DECLARATIONS OF INTEREST

There were no declarations of interest.

88.18 CHAIRMAN'S REMARKS

The Chairman advised that he would be opening the Amelia's Rainbow Colehill Fun Day on 12 August. He also advised that there had been a further break in at Wimborne Cemetery.

89.18 MINUTES

The Minutes of the Annual Council meeting held on 22 May and the Special Council meeting held on 26 June were submitted.

RESOLVED that the Minutes be approved and signed.

90.18 MATTERS ARISING ON THE MINUTES

30.18 Arrangements were being made for a digital certificate to be added to the Council's website. Further information on this would be provided at the next Finance and General Purposes committee.

34.18 DAPTC would be organising some planning training in the autumn.

68.18 The map board would be finished in October.

91.18 COMMITTEE REPORTS

(a) HIGHWAYS & PLANS – 5 June

The report of the Meeting was submitted.

43.18 Cllr Mitchell had made enquiries regarding the proposed school on PA 3/17/0848/FUL and confirmed that, at present, there were no plans available.

52.18 A broken road name sign at Lapwing Road had been reported to EDDC.

RESOLVED that the report be approved and adopted.

(b) FINANCE AND GENERAL PURPOSES – 5 June

The report of the Meeting was submitted.

65.18 (h) The Colehill Gardens Gadabout event had been a great success.

RESOLVED that the report be approved and adopted.

(c) HIGHWAYS & PLANS – 26 June

The report of the Meeting was submitted.

72.18 EDDC had confirmed that the Council's Highways and Plans Committee could not re-consider PA 3/18/1387/HOU – 5 Quarry Close.

79.18 DCC had advised that the bus cages for Wimborne Road were to have been considered once the school keep clears had been in place for a few months. If the school keep clears had improved matters then the bus cages would not be needed. However, if there was now a problem with buses regularly not being able to access the bus stop then it could be considered. DCC had not received any information from the bus companies reporting any problems.

85.18(f) EDDC had advised that it was possible that some of the Community Infrastructure Regulation money, in relation to the Bloor Homes development, would be released by the end of the summer.

86.18 Cllr Packer advised that EDDC had accepted the new Government legislation on planning permissions. Cllr Packer said that this would impact on Members' involvement and that this matter should be considered at a future Highways and Plans committee.

RESOLVED that the report be approved and adopted.

92.18 BOUNDARY REVIEW FOR DORSET COUNCIL

The Members considered the Local Government and Boundary Review Working Party's draft submission and noted that the finalised submission would be ready in time for approval at the Special Council meeting on 21 August, in time for the Local Government Boundary Commission for England's deadline of 27 August.

93.18 COMMUNITY ASSET TRANSFER

Cllrs Dover, Johnson and Packer, and the Clerk, reported on the meeting they had attended with the Head of Community and Leisure from Christchurch and East Dorset Councils.

There were a number of assets that the Council could consider, however the Head of Community and Leisure (HCL) advised that a limit had been set on the amount that could be transferred to parish and town councils due to the short timescale involved. Any assets that were not transferred now could always be applied for in the future. The HCL further advised that it was proposed that C&EDC would pay its legal costs and parish and town councils would pay their own legal costs.

The HCL confirmed that the Furzehill woodland site was within the site being sold so could not be transferred to Colehill PC at this stage pending exchange of contracts.

A submission had been prepared to apply for Oliver's Park play area, Oliver's Park field and Churchmoor Copse to be transferred to the Parish Council, a copy of which appears as Appendix 1 to these Minutes in the Minute Book.

RESOLVED that the submission be approved.

94.18 DAPTC AGM RESOLUTIONS
