### 335.17 DCC AND CPC WORKING TOGETHER

This gave an equivalent Parish Council Tax Levy of £34.50, a 13.1% increase on that for 2016/17 (£33.00). With a predicted income of £13,090.42, the amount that would need to be drawn from reserves would be £8,113.86.
