7. Litter Bin (Minute 45.16 refers)

DWP has been informed of the problem of overflowing litter bins at Cannon Hill Road (and also at Middlehill Road, by Charlton Newell) and has advised that, where there is evidence of a resident disposing of their own domestic household waste, DWP can enforce this and possibly fine them. With regard to having an additional litter bin, DWP would supply a wheeled bin, but as it is an additional bin the Council would have to pay for the bin and the emptying of it on a weekly basis. (The costs will be available at the meeting).

To decide whether there is sufficient evidence to involve Enforcement or whether to pay for a new bin and weekly emptying. Any decisions on expenditure will need to be approved at Finance and General Purposes Committee or Council.
