8. Ashmeads Way Cycle Barriers

The DCC Community Highways Team Leader has considered the request for barriers at Ashmeads Way and has advised that he is primarily against installing barriers. He would support putting up no cycling signs at both ends as an alternative (email correspondence attached on cream paper). DCC has further advised that the Parish Council could pay for the installation of the barriers at a cost of £778.00 excluding VAT (quotation attached on blue paper).

To decide whether to pay for the installation of the barriers or whether to ask DCC to install no cycling signs.

13. Colehill FP 46

To Note that DCC has advised of another small change to the working copies of the definitive map and statement of public rights of way affecting Colehill. An officer from the regulation team has advised that when reviewing an old file containing an application to add a footpath from Colbourne Avenue to Leigh Lane it was noticed that, although the application had been withdrawn due to the path already being an 'adopted' estate path and on the List of Streets, the consequential addition of the path to the definitive map and statement had not been actioned. This has now been done and the path has been numbered as Footpath 46, Colehill. The legal change will be made by the next bulk modification order at the end of the year.

14. Oliver's Park

To revisit the idea of CCTV being used at the Park due to the antisocial behaviour that is occurring.
