#### 13. Remembrance Day Parade

At last year's Remembrance Day service and parade one member of the public complained to the police that Wimborne Road had not been closed at the same time as Colehill Lane.

As Members know, the police are no longer able to provide officers to stop the traffic and road closures for these events are now the responsibility of parish and town councils.

At the moment the Council applies for Colehill Lane (between the junctions with Wimborne Road and Smugglers Lane) to be closed. This has a minor effect on any traffic as very few vehicles need to access this stretch of Colehill Lane on the morning of the closure.

The Clerk has investigated what would be required to close Wimborne Lane. DCC's advice has been sought and a response is awaited, however, it seems that a large diversion for such a closure would be required, with more traffic management equipment and more representatives manning the road closure and diversion points. Such a closure would also involve informing all property owners in the immediate area and the public transport companies.

Members to decide whether to pursue the closure of Wimborne Road or to continue with the closing of Colehill Lane only.
