481.17 TEMPORARY ROAD CLOSURE

Members NOTED that DCC had advised that Burts Hill, from the junction with Allenview Road to the junction with Greenhill Road, would be closed from 15 May for 21 days with an end date of 4 June. The road closure was necessary for safety reasons and would allow Bournemouth Water to carry out water main replacement work.

482.17 LEIGH COMMON

Members NOTED that DCC had advised that an application had been made under Section 19 of the Commons Act 2006 to correct the register of common land in respect of Leigh Common, on the basis that the area in question ought not to have been registered as common land as it was highway at the time of registration.

483.17 PARKING PROBLEM – BRIDLE WAY

Members considered correspondence from a resident regarding a parking problem in Bridle Way. It was decided that it was unlikely that Dorset County Council would introduce a parking scheme in the area due to financial constraints and because similar parking problems had been refused in the past. However, it was AGREED that the Council should reiterate Cllr Dover's request that the PCSOs regularly attend the site to ensure that vehicles were parking appropriately.

484.17 LAND ADOPTION

A local developer had asked the Council to consider adopting some land at Bridleway. It was AGREED that Cllr Mitchell and the Clerk would ask for further information from the developer and seek advice from NALC, in order that the matter could be considered in due course.

485.17 PUBLIC BENCHES

Members NOTED there were no faults to report. Cllr Ian Dickins advised that Cllr Linda Dickins had removed the overgrown vegetation from the bench at St Michael's Church. Cllr Johnson reported that the plaque on the bench at Weston Road needed to be cleaned.

486.17 WAR MEMORIAL/BUS STOP

Members NOTED there were no faults to report.

487.17 PLAY AREA/ST MICHAEL'S DIRT

Members NOTED there were no faults to report. Cllr Urquhart said that she was not impressed with the workmanship on the playground equipment. The Clerk advised that this had been discussed at the previous meeting and that she and Cllr King had arranged to discuss the matter with the managing director of the company that had carried out the work. Steps would also be taken to organise some type of project management team that could assist the clerk with any large projects in the future.

489.17 HIGHWAY MATTERS FOR REPORT
