220.17 DECLARATIONS OF INTEREST

There were no declarations of interest.

221.17 ANNUAL TREE SURVEY REPORT

The Clerk advised the Members of the recent tree survey that had been conducted, a copy of which was distributed to those Members present. One tree adjacent to Smugglers Lane would be dealt with promptly, but the remaining tree work had been given a priority work order of 3 or 4, which means that the work needs to be done within six months.

Cllr King advised that he and the Clerk had inspected all of the trees that had been listed and would be raising two further matters with the tree inspector. Cllr King said that the report had mentioned that the trees at Coombes Wood would benefit from a tree management programme. He wondered whether a local tree surgeon who was involved with the BMX track would be able to make some suggestions about this. The Clerk said that she would try to contact the tree surgeon.

The Clerk further advised that a resident at Kyrchil Lane had telephoned to explain that branches from the Council's trees were jutting out over the highway and that other branches were overhanging a communal driveway. The Clerk and Cllr King had visited the area and determined that the branches jutting out over the highway should be cut back, but that the householder(s) should arrange for the branches overhanging the communal driveway to be cut back. Members AGREED with this decision.

224.17 WIMBORNE ROAD

Members NOTED that the DCC Community Highways Officer had advised that Beaucroft School had cut back their overgrown vegetation from the pavement, however this had now highlighted the uneven surface. He had carried out an adhoc survey and raised the defects to ensure the footpath was safe to use for now, he had also added this section (from adjacent the School gates to the Cobbs Road junction) onto DCC's Capital Requests list for footway resurfacing. This would be considered along with other requests from all over Dorset and prioritised accordingly. In the meantime the area would be monitored through DCC's scheduled Highways inspection programme to maintain the current condition.

225.17 SMUGGLERS LANE

Members NOTED that the resurfacing and patching works of Smugglers Lane had been postponed to a future programme due to ongoing extensive drainage works in the area.

226.17 CONSULTATION

Members NOTED that NALC was seeking responses to the Department for Communities and Local Government consultation on Planning for the right homes in the right places.

227.17 DEFINITIVE MAP AND STATEMENT OF PUBLIC RIGHTS OF WAY

Members NOTED that DCC's Definitive Map Technical Officer had advised that there was a small change to the working copies of the definitive map and statement of public rights of way affecting Colehill.

While checking the route of Bridleway 11 it was noticed that the definitive map did not record accurately the change made as a result of the "Folkestone-Honiton Trunk Road (Ferndown Bypass, Side Road) Order 1983". The Order diverted a small part of Bridleway 11 where it crossed the bypass, but the definitive map shows the bridleway slightly too far away from the road and also the statement was not updated at the time.

228.17 HAYES LANE STREET FURNITURE

Members discussed the possibility of installing a notice board and public bench on the DCC owned grass verge on Wimborne Road West, at the junction with Ham Lane, and AGREED that the purchase of both items should be recommended to Council on 7 November.

229.17 EDDC'S PLANNING REGULATIONS

Members NOTED that West Moors PC councillors supported the Parish Council's dissatisfaction of the increase from 5 people to 10 people in objections required before a planning application could go to committee, but was uncertain as to how they could help. Members AGREED that it was unlikely that EDDC would reconsider the new rule, but that they should be asked to clarify who determines what a substantial reason is and how it is different to a material reason.

230.17 BEAUTIFICATION OF THE CANFORD BOTTOM ROUNDABOUT

Cllr Webb presented his proposal to tidy and improve the grass areas at Canford Bottom roundabout. The Members supported his proposal and AGREED that this Committee would recommend supporting it to Council on 7 November.

231.17 ANNUAL INSPECTION REPORTS AT OLIVER'S PARK PLAY AREA AND ST MICHAEL'S DIRT

The Clerk advised the Members of the recent annual inspections that had been carried out at Oliver's Park Play Area and at St Michael's Dirt. Copies of the reports were distributed to those Members present.

All of the matters highlighted at Oliver's Park were of low risk or very low risk, however the Clerk would arrange for the requirements to be carried out and monitor the areas that had been highlighted.

The inspector had risk assessed St Michael's Dirt as moderate risk, but had noted that the area was well maintained. The report would be sent to the lead rider for his information and Members would continue to inspect the site weekly.

- (b) The Manager from DCC Highways had advised that he was primarily against putting up a barrier at the Ashmeads Way footpath, but would consider No Cycling signs as an alternative. The Clerk had asked for further information and this matter would be considered at a future meeting.

236.17 ITEMS FOR DISCUSSION AND FUTURE AGENDA

- (a) The Co-op Post Office would be closed for refurbishment from 24 October to 29 November. Posters would be displayed and the information posted on social media.
- (b) East Dorset District Council was discussing organising free community health walks with St Michael's Church, as it was hoped that the walks could tie in with the Church's monthly coffee mornings in 2018.
- (c) The new bin had been installed at Wimborne Road, junction with Greenhill Lane. A further logo would be ordered for this bin and for the one at Middlehill Road, junction with Weston Road.
