425.18 SMUGGLERS LANE – TEMPORARY ROAD CLOSURE

Members NOTED that DCC had issued a Notice to close Smugglers Lane between 25th June and 29th June between the hours of 09.30 and 15.30 daily to carry out maintenance work. It would be reopened at night and at weekends.

426.18 ROWLANDS HILL - TEMPORARY ROAD CLOSURE

Members NOTED that DCC had issued a Notice to close Rowlands Hill between 2 April and 6 April 2018. This closure was required to enable contractors to install a SSE Telecoms duct in relation to a fibre project being undertaken in the area.

427.18 HGV INFORMATION

DCC had provided an update on the Council's request for a HGV ban at Middlehill Road and had advised that the outcome of the Policy Development Panel was the formation of an updated Freight Strategy Action Plan. DCC said that this document had a strategic focus covering the whole of Dorset, Bournemouth and Poole and would be reviewed and updated every six months. DCC also highlighted that a big problem that was discussed during the process of preparing the Freight Strategy Action Plan was enforceability. In the event of a Traffic Regulation Order (TRO) being made, this would become a moving traffic offence and therefore a police matter. However, a TRO banning HGV will move all HGV to be someone else's problem as the freight still needs to happen. DCC also advised that banning HGVs raised the question of how a journey was differentiated and also the scale of HGVs, for example, anything above 3.5 tonnes is a HGV2 so this could preclude some "white van man" deliveries.

DCC advised that if the Parish Council was concerned about the Cranborne Road development construction traffic then the construction management plan should ensure that all of the construction vehicles avoided Colehill.

428.18 GRIT BIN REQUESTS

The Clerk advised that requests had been received for grit bins to be installed at Greenbottom and Heron Drive.

In considering both requests, the Members noted that DCC had confirmed that Greenbottom was an unadopted road and, therefore, unable to service a grit bin on this road. It was also noted that there were grit bins at Lapwing Road and Mallard Road and that Heron Drive residents could collect grit from these bins in preparation for icy weather. It was, therefore, RESOLVED that no grit bins be purchased for Greenbottom or Heron Drive.

429.18 TRAFFIC DATA – PILFORD HEATH ROAD

The Members considered the results of the DCC traffic data that had been collected at Pilford Heath Road and AGREED that the results would not warrant DCC taking any action, however the Clerk would forward the data to the Police for information.
