46.18 TEMPORARY ROAD CLOSURES

DCC had issued a Notice prohibiting vehicles from proceeding along a section of the road past Bedborough Farm. The notice was needed in order to comply with Health and Safety Regulations which required the provision of safe working areas and to minimise likelihood of danger to Highway Users. It would come into operation on the evening of 22 May 2018 after 19.00 and remain in force for 5 days.

DCC had issued a Notice prohibiting vehicles from proceeding along; [1] God's Blessing Lane between Holt Lane and Hart's Lane; [2] Hart's Lane between Holt Lane and Colehill Lane; [3] Pilford Lane between Colehill Lane and Uddens Drive; [4] Uddens Drive between A31T and Uddens Drive (Uddens Park). The notice was needed in order to comply with Health and Safety Regulations which required the provision of safe working areas and to minimise the likelihood of danger to Highway Users. It would come into operation on 29 May 2018 and remain in force for 5 days.

DCC had issued a Notice prohibiting vehicles from proceeding along Smugglers Lane from the junction with Furzehill to the junction with Colehill Lane, a distance of approximately 1,370 m. The Notice was needed in order to comply with Health and Safety Regulations which required the provision of safe working areas and to minimise the likelihood of danger to Highway Users.
