401.08 DECLARATIONS OF INTEREST

402.08 MINUTES

The Minutes of the Meeting held on 29 January, having been circulated, were taken as read, confirmed and signed.

403.08 MATTERS ARISING

There were no matters arising.

404.08 DOG FOULING PATROLS

In order to enforce existing dog fouling legislation, East Dorset District Council wished to increase the level of patrols in the area and had requested a contribution towards the cost of the patrols on Council owned land. EDDC envisaged a 'bank of hours' type arrangement whereby the hours would be spread across the year or targeted at more specific times to deal with particular problems. It was estimated that the cost would be £15 per bank hour.

Councillors queried whether there was a dog fouling problem in Colehill. Cllr Packer advised that according to the parish plan residents did consider dog fouling to be a problem, and proposed that £750 per year be paid to EDDC and £250 be used to fund a public awareness campaign, seconded by Cllr Holloway.

RESOLVED that £750 per year be paid to East Dorset District Council and £250 be used to fund a public awareness campaign in Colehill. Unanimous.
