325.08 ACCESS TO CROSS THE COMMON LAND

The owner of 9 Kyrchil Way informed the Council that her tenant had arranged for a large vehicle to cross the common land over the Christmas period without seeking permission. The owner apologised and explained that her tenant was now fully aware of the requirement to seek permission to cross the land.

The owner of 11 Kyrchil Way had requested permission for a vehicle to cross the common land on 8 January 2008 to collect a skip. Permission had been granted.

326.08 SPEED POLE – SMUGGLERS LANE (Minute 307.07 refers)

Correspondence had been received from DCC's Management Engineer regarding the speed pole obstructing the footpath and the Council's concerns that residents had not been listened to. The Management Engineer confirmed that the location of the pole was based on technical advice. He also considered that the residents had been listened to and that discussions had resulted in a wooden post being removed to create more space. He further commented that until this matter was resolved, he could not recommend a public consultation on the Middlehill Road traffic calming scheme.

RESOLVED that the Management Engineer be informed that the Council fully supports the scheme and requests that a public consultation be held as soon as possible. Should any further problems occur with the scheme Members were advised to contact County Cllr Janet Dover who could liaise with DCC on their behalf.

327.08 IDENTIFICATION OF NEW SITES FOR HOUSING
