428.08 PA 3/08/0088/FUL – 10 PARMITER DRIVE

The above Planning Application was considered at EDDC's Planning Committee on 1 April 2008. Cllr Phillips attended the meeting to speak about the application on behalf of the Council.

429.08 FOOTPATH, WIMBORNE ROAD (Minute 382.08(g) refers)

The owner of Colehill Garage had confirmed that the forecourt, which ends at the roadside, was his property and that there was no footpath for pedestrians on the forecourt.

430.08 CCTV

Members were informed that the CCTV had recorded the theft of a bicycle from outside the Co-op. The Police were investigating the incident.

431.08 PROPOSED CHANGES TO THE PLANNING APPLICATION REGISTRATION REQUIREMENTS

Members were informed of the new Government regulations requiring applicants for planning permission to comply with new requirements concerning the standard and content of planning applications. These changes would include the introduction of standard application forms (1APP) from 6 April 2008. To support the use of 1APP, the Government was also introducing new information requirements for the validation of planning applications. These would specify the documentation and

information required for a valid application to be registered. A copy of the Planning Application Requirements was available at the meeting.

NOTED.

432.08 SPEED LIMITS

A letter had been received from the Colehill Evening Women's Institute, a copy of which had been circulated to each Member.

The letter requested that the Council support the Colehill Evening Women's Institute's campaign to reduce speed limits outside Dorset schools to 20mph.

RESOLVED that the Chairman of Council respond to the letter, expressing the Council's support of the campaign and highlighting the Council's active involvement in reducing the speed limit through the Speed Indicator Device and the traffic calming measures at Middlehill Road.

433.08 PLANNING PROCESS

A letter had been received from West Moors Parish Council, a copy of which had been circulated to each Member.

West Moors Parish Council had written to East Dorset District Council expressing concerns about the planning process and had suggested that other parish and town councils write to EDDC if they also had concerns.

After discussion it was agreed that Members would benefit from attending regular Planning training sessions and that Dorset County Training Partnership should be contacted again to request an evening training session on Planning.

RESOLVED that West Moors Parish Council's letter be acknowledged explaining that this Council plans to request more Planning training sessions.

434.08 PROPOSED FLYER ON NUISANCE VEHICLES

Since commencing the street corner meetings PC Brett had confirmed that residents were concerned about parking issues and had agreed that the wording on the flyer would be altered to read "Dorset Police, supported by Colehill Parish Council".

PC Brett requested that the Council fund the printing of the flyers and this matter would be discussed at Finance and General Purposes Committee on 29 April 2008.

PC Brett had reported that young people were congregating outside the Co-op and St Michael's Church at weekend evenings. He requested that Councillors inform him of any complaints they receive to enable him to evidence the problem.

435.08 SPEED INDICATOR DEVICE

Cllr Johnson reported that the SID would be situated at Holt throughout April and that the Police had appreciated receiving the SID data.

436.08 HIGHWAY MATTERS FOR REPORT

- (a) Cllr Johnson reported on the recent conservation day. He and fellow volunteers had flattened some humps in Triangle Wood which were being used as a BMX track.
- (b) Cllr Warren had been informed by PCSO Matt Johnson of plans to involve young people in community work. Advice from EDDC's Community Safety Officer had been forwarded to him.
- (c) Cllr Warren had been informed through PACT that the Forestry Commission was considering assisting young people to make a BMX track at Cannon Hill Plantation.
- (d) Cllr Johnson reported that advice was being sought on the duration of the work on the gas governor at the junction of Pilford Heath Road with Middlehill Road.
- (e) Cllr Johnson reported that DCC would not repaint the yellow lines at the Co- op crossroads as it was the wrong time of year for this work. New orders were planned in the area and when this work took place the repainting would also be done.
- (f) Cllr Johnson had contacted DCC to discuss claiming a right of way for the path which runs from Middlehill Road, opposite the old Colehill First School site, into Ashmeads Way.
- (g) Cllr Holloway was concerned with the amount of litter in the East Dorset area. The Clerk to contact EDDC to determine when the litter picks were scheduled.
