137.09 <u>TREE MATTERS</u> <u>PERMISSIONS FOR TREE WORK</u>

(a) EDDC had granted permission for tree surgery work as follows:

ORDER	DETAILS
CO/82	Grant consent for Beech in front garden of 11 Quarry Road to be crown lifted to a maximum height of 3.5m above ground level. Live pruning wound shall not exceed 60mm in diameter.
CO/95	Grant consent for Beech, Oak and Pine (G1) to be crown lifted by 4m from ground level, ensuring no live pruning wounds exceed 40mm in diameter at Triangle Wood. Requested by the owner of 1 Richmond Villas, Wimborne Road as the trees were overhanging her property. The applicant had requested confirmation from the Council as to who should arrange for the work to be completed. It was decided that as the trees were not presenting a hazard the owner of 1 Richmond Villas should arrange and pay for the tree work.

140.09 ACCESS ACROSS COMMON LAND

Matrod Frampton had requested that permission to drive over the common land be extended until 21 August, in order that the work at the rear of 7 Kyrchil Way could be completed.

The owner of 7 Kyrchil Way had explained that she had not authorised Matrod Frampton to access the land, but was grateful that an amicable arrangement had been agreed. The owner still wished to apply for an access licence and this would be discussed at Highways and Plans Committee on 3 November.

Cllr Mitchell confirmed that he had met Mr Frampton on site to inspect the work done to reinstate the track and re-install the bollards, and advised that the work had been completed satisfactorily.

141.09 CANNON HILL AND UDDENS PLANTATION

The Forestry Commission had withdrawn Cannon Hill and Uddens Plantation from the Minerals Site Allocations Document mainly because the contractor did not wish to continue with the project. It was possible that the Forestry Commission would have both sites reconsidered at a later stage.

142.09 HGV'S ON UNSUITABLE ROADS

DCC had advised that they would not consider a weight restriction on the narrow part of Beaucroft Lane due to the policing issues associated with such a ban, in that the legal order included the phrase "except for access" which made it difficult to establish whether access was legitimate or not.

DCC had also advised that the positioning of the "unsuitable for HGV's" sign on the downhill section of Beaucroft Lane could be better placed, but that there was no alternative place suitable.

- (d) Cllr Warren reported that the improvement work on the lay by in Wimborne Road was almost completed.
- (e) Cllr Bartlett reported that the road name sign at Bridle Way, on the lower side, needed resetting. EDDC to be informed.
