# 254.09 ENFORCEMENT

An Enforcement Notice had been served on the owner of land at Greenhill Road as a gravel surface car park had been constructed without planning permission.

EDDC's Enforcement Team had confirmed that they would contact the owner of land opposite Westwood Oaks, Pilford Lane, to discuss the rubbish that had accumulated there. The Enforcement Team had also confirmed that following feedback from the enforcement training sessions, monthly reports would be sent out to parish and town councils advising of recent enforcement cases.

# 255.09 HGV'S ON UNSUITABLE ROADS (Minute 142.09 refers)

DCC had confirmed that although the signage would be improved in North Leigh Lane and Beaucroft Lane, a weight restriction would not be made in Beaucroft Lane because it would be unenforceable.

# 256.09 ADDITIONAL STREET LIGHTING – LEIGH LANE (Minute 195.09 refers)

DCC had confirmed that the request for an additional street light in Leigh Lane would be investigated after 31 March 2010. The investigation would take account of crime, accidents, environment and local support to produce a final score. This score would be compared against other lighting schemes and if the score was high enough and funding was available then the improvement would be made.

# 257.09 NO THROUGH ROAD SIGN, LEIGH ROAD (Minute 209.09 refers)

DCC had confirmed that EDDC would erect a sign setting out the house numbers accessible from the road and also a no through road sign at the entrance to the road.

# 258.09 FLY TIPPING ON PRIVATE LAND (Minute 210.09 refers)

EDDC was unable to remove fly tips from private land without making a charge. Should a landowner be unable to remove the fly tipped waste then the charged clearance service would be offered at prices equal to the bulky household waste collections.

In 2009 EDDC prosecuted two individuals for their involvement with fly tips in the district. EDDC could not secure the prosecutions for fly tipping as there was insufficient evidence, however the individuals pleaded guilty to transporting waste without a Waste Carrier's Licence.

#### 259.09 BROOK ROAD (Minute 211.09 refers)

EDDC had confirmed that the recycling banks at Brook Road would be relocated to other areas in the district. The sites would be monitored and any increase in tonnage would be managed accordingly. EDDC had also confirmed that no banks were being moved to Allenview Car Park as this site had a good range of recycling banks.

# 260.09 TRAFFIC SPEED – LEIGH ROAD (Minute 212.09 refers)

DCC had completed the tests to gauge the traffic speed on Leigh Lane (the stretch from Tops Nursery to North Leigh Lane junction) and had concluded that the speed limit of 40mph was consistent with the speeds being driven. DCC considered that drivers would not adhere to a 30mph speed limit without it being enforced regularly.

# 261.09 BUS SERVICE AT LEIGH ROAD (Minute 213.09 refers)

DCC had confirmed that the Nordcat 88 bus travelled from Hayes Lane along Leigh Road and, although the bus stop flag had been removed, passengers could flag the bus down and travel to Wimborne. The return journey would tour the rest of the parish, but did return to Leigh Road on its way back to Wimborne.

The Damory service 315, stopping at Leigh Road, would take passengers to Ringwood on Wednesdays and service 321, stopping at Leigh Road, would take passengers to Wimborne and more directly back on Fridays. On Wilts and Dorset service 3 journeys to Poole were available from Gordon Road bus shelter (peak morning and late afternoon).

#### 262.09 SPEED INDICATOR DEVICE

Cllr Baker reported that the SID would be installed at Holt.

The Clerk advised of a resident's dissatisfaction with the Committee's decision to not investigate whether a SID pole could be installed at Beaucroft Lane. (Minute 239.09 refers).

#### 263.09 HIGHWAY MATTERS FOR REPORT

- (a) Footway resurfacing work had commenced in Cutlers Place, completing by 11 December.
- (b) Residents had requested that DCC resurface Footpath 17 (Leigh Lane to Park Homer).
- (c) DCC would commission a SID assessment in Hayes Lane.
- (d) DCC would place 6 bollards on the outer edge of the grass verge in Wimborne Road, close to Beaucroft School, to prevent vehicles from parking on it.
- (e) DCC Public Rights of Way had confirmed that the designated status of the Kyrchil Wood footpath would not change and that cyclists would have permissive rights only.

- (f) Correspondence had been received from a resident complaining about the traffic calming at Middlehill Road. An acknowledgement would be sent and the letter copied to DCC.

- (h) Cllr Francis reported uneven pavements on the Parmiter estate. The Clerk to provide Cllr Francis with Julie Wharton's contact details.
- (i) PCSO Matt Johnson was investigating the installation of bicycle rails and two further notice boards at the Co-op.
