480.12 DECLARATIONS OF INTEREST

There were no declarations of interest.

481.12 COLEHILL AND WIMBORNE YOUTH AND COMMUNITY CENTRE

Mr Torring advised Council that the project did not meet the criteria of the Coastal Communities Fund so they could not apply for funding. He had spoken to Chris Carmen at DCC who advised him that there was very little money available and more projects looking for funding. Mr Torring said that they would have to revisit the project, go back to basics and scale it down. They would determine the essentials to meet certain criteria (eg needs for disabled users) and then see what funding they could apply for. He had visited a project in Yeovil, Five Ways Special School. It had cost £400,000 to build the single story building. The footprint was not as large as The Reef but it did have a lot of parking and landscaping. He would go back to the architects to see if it was possible to adapt the existing building, but they would have to consider the costs verses outcomes. It may be more cost effective to build a new building but they would have to provide the best building for the money they have: it had to meet the needs of the young people and the wider community. He would be discussing this with his fellow trustees and would report back to the Parish Council at the next meeting. It was important to get a decision and to move forward.

482.12 BIG BIKE RIDE

Mr Torring provided a budget for the advertising and promotion of the Big Jubilee Bike Ride. Some of the leaflets, posters and adverts could be used to promote both the Garden Gadabout and the bike ride.

Cllr Warren proposed donating £500 towards the Big Bike Ride, seconded by Cllr Dover. Unanimous.

RESOLVED that the expenditure of £500 towards advertising and promotion of the Big Bike Ride be approved.

483.12 CHAIRMAN'S REMARKS

The Chairman advised that Stapehill residents were working very hard opposing the Gypsy and Traveller Site at Uddens. He had spoken to them about writing to EDDC planning department not just relying on their epetition. They currently had almost 7000 signatures.

Cllrs Dover advised that at a meeting at 10.00am on 26 April at DCC, the petition would be presented to Council and she would put forward a motion to build the Gypsy site elsewhere, remove the Uddens site from further consideration and no further action be taken as Uddens was never included in the Core Strategy for East Dorset. Michael Gorse and George Russell from the Stapehill Action Group had already presented a copy of the petition to Cllr Spencer Flower, Leader of EDDC, together with a letter opposing the site, and an ecological report from Hilary Chittenden. She advised that 50% of the people who had signed the petition were Colehill residents, which proved just how much Uddens was used by local people for recreation.

484.12 MINUTES

The Minutes of the Council Meeting held on 6 March were submitted.

485.12 MATTERS ARISING ON THE MINUTES

<u>462.12</u> Dumpton School had now replied. Cllr Warren had contacted Beaucroft and Colehill First schools, both of whom would be replying to the Clerk.

<u>430.12 Reports</u> – DCC - replace "Budget" with "Council Tax" (line 2). Colehill Memorial Hall Management Committee - Cllr Johnson advised that the thermostat in the Betty Webster committee room had been replaced.

Editorial Board – Cllr Johnson was still trying to get Adido to make the changes to the website.

486.12 <u>COMMITTEE REPORTS</u>

(a) <u>HIGHWAYS & PLANS – 13 March</u> The report of the Meeting was submitted.

435.12 – 390.12 (a) must push for more parking wardens on Lonnen Road as now becoming a major problem area. It was

suggested that the Council contact Miles Butler, Director of Environment.

<u>439.12</u> – Cllr Dover had not heard how much of the costs would be borne by the Highways Agency but the repairs to Lonnen Road were definitely scheduled to be done. The Highways Agency would meet most if not all, of the costs. The SID data had been forwarded to DCC confirming the huge increase in traffic since the Canford Bottom Road works started.

444.12 Cllr Warren said the seat at Parmiter still had not been removed. Cllr Johnson advised that an email had been received listing when jobs would be done.

445.12 Cllr Mitchell advised that the latest copy of the Core Strategy was now available.

455.12 Burts Hill. Cllr Davies commented that the road was being dug up yet again. Last year it was the gas board, now the water board. Surely these works could be co-ordinated more so that there was less disruption, inconvenience and expense. Colehill Parish Council and Wimborne Minster Town Council to liaise more about road works.

488.12 AMENDMENT TO STANDING ORDERS

RESOLVED that the revision that the National Association of Local Councils had made to Model Standing Order No 32 (Variation, revocation and suspension of standing orders) be approved as follows:

from:

a Any or every part of the standing orders, except those which are mandatory by law, may be suspended by resolution in relation to any specific item of business.

b A motion to permanently add to or to vary or to revoke one or more of the Council's standing orders not mandatory by law shall not be carried unless two-thirds of the councillors at a meeting of the Council vote in favour of the same.

to:

- a. Any or every part of the standing orders, except those which are mandatory by law, may be suspended by resolution in relation to any specific item of business.
- b. A motion to add to or vary or revoke one or more of the Council's standing orders, not mandatory by law, shall be proposed by a special motion, the written notice whereof bears the names of at least 3 councillors.

489.12 LOCAL COUNCIL ADVISORY SERVICE

LCAS would be holding its annual health and safety seminar on 29 May, at Blandford, at 9.30 am to 1.15 pm.

As a member, the Council received one free space, further spaces cost £30 per person (non members were charged £60).

Discussions at the seminar would include lone working, principal authorities delegating services to parish councils and winter maintenance.

490.12 CHRISTCHURCH AND EAST DORSET CORE STRATEGY 2013-2028

Christchurch Borough Council and East Dorset District Council had jointly published the core strategy for consultation. This document sets out the planning strategy for Christchurch and East Dorset over the next 15 years.

RESOLVED that the Core Strategy be noted.

491.12 QUEEN'S DIAMOND JUBILEE (Minute 468.12 refers)

Cllr Mitchell brought copies of the books thought suitable to give as gifts to each of the six schools within Colehill. It was unanimously decided to select "Elizabeth Diamond Jubilee Portrait" and unanimously agreed to expenditure costs of £650.

Cllr Mitchell would order the books and 18 book tokens (£20 each) from Gullivers Book Shop in Wimborne, who would give CPC 10% discount on all purchases.

Cllr Davies would get the costs for certificates to give to each child in commemoration of the Jubilee.

RESOLVED that the £650 expenditure for prizes and gifts be approved.
