### **227.12 MINUTES**

#### (c) The Sting in the Tale

Proposed by Cllr Johnson that £150 be awarded to The Sting in the Tale, seconded by Cllr Mitchell. All in favour.

RESOLVED that a donation of £150 be approved under Section 145 of the 1972 Local Government Act.

#### (d) The Reef

Proposed by Cllr Mitchell that £300 be awarded to The Reef, seconded by Cllr Johnson. All in favour.

RESOLVED that a donation of £300 be approved under Section 19 of the 1976 Local Government (Miscellaneous Provisions) Act.

# (e) <u>Girlquiding – Colehill District</u>

# 232.12 ELECTORAL REVIEW OF EAST DORSET

The Review Officer at the Local Government Boundary Commission had advised of the latest consultation.

Members thought that the Review Officer should be asked to consider dewarding Colehill Parish. At the moment there were four wards (East = 9 councillors, West = 4 councillors, Parmiter = 1 councillor, Lacy = 1 councillor)

Very often at election time, there were too many representatives for one particular ward (prompting an election) and not enough for another ward. If Colehill Parish was de-warded there would only need to be an election if there were more than 15 people standing. Councillors represented the whole of Colehill Parish anyway, not just the ward they were elected for, and so it would make sense to de-ward.

RESOLVED that the clerk advise the Review Officer that the Council would like Colehill Parish to be de-warded.

# 233.12 INTERNAL AUDIT
