235.10 DECLARATIONS OF INTEREST

There were no declarations of interest.

236.10 CHRISTCHURCH AND EAST DORSET CORE STRATEGY OPTIONS FOR CONSIDERATION

The Chairman invited Richard Henshaw to introduce the Core Strategy and to discuss the issues and options affecting Colehill.

Richard stressed the need to consider the potential options and what facilities the Parish would like to see with reference to the Colehill Parish Plan.

Councillor Francis said he had been contacted by residents who were concerned about the development of a sports village and new housing behind them on the Parmiter estate. Richard said that he hoped they would attend the local exhibitions so that they could air their concerns.

Councillor Warren asked what the definition of 'affordable housing' was. Richard referred to the definition in the Local Plan which sets out that it relates to the ability of households to afford to either rent or buy within the private market.

Councillor Holloway raised concerns about traffic that could be generated from development at Cranborne Road which may cut through Burts Hill and Middlehill Road.

Councillor Wallace asked if the sites were in the Green Belt. Richard and Sally confirmed that they were mainly Green Belt areas.

COUNCIL MEETING - 2 NOVEMBER 2010

Councillor Mitchell suggested there was a need for a doctor's surgery in Colehill. Richard said that discussions were being held with Victoria Hospital and the Quarter Jack Surgery regarding expansions.

Councillor Davies had a series of questions about the proposed options (which were asked in her absence):

- What proportion of the 550 homes would be designated as 'affordable housing'? Richard said there could be up to 40–50%, although it may be that a proportion or financial sum may be taken off site.
- Extending First School and Middle School Provision. Richard said this
 had been taken into account and EDDC was in discussion with DCC
 about future needs. Provision for a new school had been made in the
 site at Cranborne Road.
- Future employment. Richard explained about the potential employment growth options in the Core Strategy. The Ferndown Industrial estate would be extended to the NW edge with industrial sites at Woolsbridge, Sturminster Marshall and St Leonards Hospital. Richard explained that EDDC could not insist on high wage firms, but could provide good sites and good employees to attract them into the area
- Transport. Concerns about the options and the impact on Colehill and the A31.
- Health. Will a new health centre be guaranteed? Richard explained about the possible expansion of the hospital, and that they were in discussion with the health providers to see what their future needs would be.
- New EDDC offices. If the offices were to be relocated, the Council would need to decide on the future use of Furzehill.
- How long before we see any development on site? The Core Strategy should be adopted in 2 years time. The Cranborne Road site already had a developer interested in developing the site. The plan period was for 15 years, but development could take place early on in the plan period if the land owner and developer agreed, and plans moved forward successfully.

Richard concluded by explaining that the development options involved 4% of the green belt in East Dorset (138 hectares out of 33,000 hectares).

The Chairman thanked Richard and Sally for attending the meeting and informed Members that a special meeting would be arranged so that the Council's comments could be collated.

237.10 CHAIRMAN'S REMARKS

The Chairman advised that he and Cllrs Davies and Warren had attended a councillors' update seminar. He also advised on the Government's plans to abolish the Standards Board for England.

238.10 CLERK'S REPORT

- (a) The Colehill PACT Panel would be holding a public meeting at Colehill Memorial Hall on 3 November.
- (b) EDDC would be arranging for Colehill to have a Give or Take Day in January or February 2011.
- (c) The One Stop shop had arranged for staff to litter pick and monitor the area around the store.
- (d) A resident had asked about the Government's plans to sell off Forestry Commission land and whether Cannon Hill Plantation would be affected. The Forestry Commission had been unable to comment as details of the Government's strategic approach to forestry in England had not been decided. Annette Brooke MP had also been contacted and a response would be reported to Highways and Plans Committee.

239.10 MINUTES

The Minutes of the Council Meeting held on 14 September were submitted.
