94.11 DECLARATIONS OF INTEREST

There were no declarations of interest.

95.11 CHAIRMAN'S REMARKS

The Chairman advised that Mr John Shave, Chairman of HomeWatch, had been awarded an MBE. A congratulatory letter had been sent from the Council.

The Chairman also advised on the Blue Haze application. This was an application for 30 years of gravel and sand extraction and then 30 years of landfill on land close to Moors Valley Country Park. All organisations were opposing it.

The Chairman had written to Mrs Annette Brooke MP opposing the cuts to Wimborne Police station. Cllr Dover, as the Dorset Police Authority representative would investigate the cuts and would inform the Clerk of any information.

The Chairman, Cllr Davies and the Clerk had met with residents of Cuthbury to discuss the comments that had been made in the Colehill Clarion.

The Chairman advised on the resignation of Cllr Jeff Morland. Arrangements were being made for the vacancy to be advertised.

97.11 COLEHILL AND WIMBORNE YOUTH AND COMMUNITY CENTRE LTD

Mr Torring advised that DEFRA were continuing to appraise the Committee's application, although they were unlikely to award the amount desired. Fundraising continued and Mr Torring thanked the Council and Cllr Davies especially for their support.

Mr Torring also advised that Co.Mad would be supporting the Reef in their next production and that Mrs B Gooch had arranged for the local members of the National Garden Scheme to fundraise for the Reef in 2012.
