Notification was received that an Appeal had been lodged into the refusal by EDDC to grant permission for erection of a 4 Bed Detached House, adjacent to 'Tree House', 6 Olivers Road.

NOTED

287.05 TRAFFIC & SAFETY ISSUES MIDDLEHILL ROAD

A serious road accident had occurred outside Howell House, Middlehill Road, on 17 December, which resulted in one fatality and injuries to two others. Members expressed their condolences to the families involved.

Correspondence had been received by the Parish Council from residents expressing their concern about traffic speed and safety issues on Middlehill Road. It was noted that the Traffic Consultant's report, commissioned by EDDC and the Parish Council in 1998, had identified the need for traffic calming on Middlehill Road and for a pedestrian refuge/crossing between Howell House and the shops (Plan B1 of the Report), the point at which the accident had occurred. Committee Members expressed disappointment that staff at DCC claimed to have no knowledge of the earlier report.

The Chairman read a reply from Steve Howard, DCC Traffic Section, in response to correspondence from residents and individual Parish Council Members following the accident. DCC had been made aware of preliminary findings of the initial accident investigation and the more comprehensive Coroner's investigations would be awaited. In the meantime, DCC had funding allocated for financial year 2007-08 for a comprehensive traffic calming scheme on Middlehill Road, including the junction with Smugglers Lane.

Statements to local newspapers, radio stations and Meridian News had been made by Cllrs John Gooch, KD Johnson, Andrew Marsh and Janet Dover. It was agreed that no further press statement would be made at this time.

Members had expressed to DCC on many occasions their concerns about traffic speed on Canford Bottom/Middlehill Road and, following a full discussion, it was RESOLVED that the attention of the County Council be drawn to the 1998 report by Paul Martin, with particular reference to Plan B1, requesting that the proposed pilot study of traffic calming measures for Middlehill Road be expedited.

288.05 SPEED LIMIT EXTENSION SITE 18b CRANBORNE ROAD

Further to Minute 278 (b)(ii), DCC were again consulting on the proposal to extend the 30mph limit for approximately 60m on Cranborne Road from the junction with Burts Hill to the Town boundary marker signs.

RESOLVED that :-

- (a) This Council support the proposed extension of the 30mph limit on Cranborne Road to the Wimborne Minster Town Boundary. As shown on the submitted plan.
- (b) Further, a request be made for imposition of a 40 mph limit on Cranborne Road from Furzehill junction within this Parish. This would include access to the hamlet of Furzehill and the point at which pedestrians en route to Wimborne cross Cranborne Road on the brow of the hill.

290.05 POST OFFICE CROSSROADS <u>PEDESTRIAN SAFETY</u>

Further to Minute 183.05, DCC had acknowledged that there was an issue with parking at the crossroads, particularly in Lonnen Road. In view of the narrowness of the pavement, together with the access and disability considerations, the use of bollards would be a last resort. In the meantime additional enforcement of the No Waiting Order would be employed.

RESOLVED that:-

- (a) The reply be noted.
- (b) In addition to the illegal parking in Lonnen Road, DCC Parking Services Dept. be requested also to pay attention to vehicles parked in the deceleration lane at Post Office Crossroads in contravention of the No Waiting Order.

291.05 SPEED ROUNDELS AND 20 MPH ZONES

Further to Minute 163, DC had advised that speed roundels were now being used on the approaches to some of the larger settlements in East Dorset to mark the entrance to the speed restriction zone. It was the intention to locate one just off Canford Bottom Roundabout when weather conditions improved and there was no salt/grit on the surface.

The use of 20mph limits outside schools was supported where a 'School Travel Plan' identified the need.
