An invitation to speak on planning application 3/07/0702/OUT (land opposite 21-27 Leigh Lane, Colehill – remove existing barn and replace with dwelling) had been received from East Dorset District Council.

#### 169.07 SOUTHERN GAS NETWORKS

Southern Gas Networks had informed the Council that a new gas governor kiosk would be installed on the grass verge adjacent to 153 Middlehill Road, replacing the one which was currently at the entrance to Cutlers Place. The size of the kiosk would be approximately 3.15 m x 3.15 m. Southern Gas Networks had advised Dorset County Council of the proposal and they had agreed the location.

RESOLVED that the Clerk write to Southern Gas Networks requesting that the new gas governor kiosk be buried underground. The company should be informed that children had been seen climbing the kiosk situated at Pilford Heath Road.

## 170.07 TEMPORARY CLOSURE OF UDDENS DRIVE, WIMBORNE

Dorset County Council had issued a Notice prohibiting all vehicles from proceeding along Uddens Drive, Wimborne, for a distance of approximately 450 metres. The Notice ran from 3 September 2007 for a period of 5 days. An alternative route had been signposted.

RESOLVED that Dorset County Council be requested to provide more notice of temporary closures in future. It was noted that the road closure of Leigh Road had exacerbated the closure of Uddens Drive. Dorset County Council be informed of this problem and asked to consider the planning of road works more carefully to avoid this happening again.

# 171.07 FOOTPATH 17 - LEIGH LANE TO PARK HOMER ROAD

(Minutes 65.07 and 139.07 refer)

A letter, which was previously circulated, had been received from a resident in Leigh Lane informing the Council that he was not the owner of Footpath 17. Cllr Johnson reported that DCC's Senior Rights of Way Officer had confirmed that the British Horse Society had submitted a request to modify the definitive map to show Footpath 17 as a bridleway.

RESOLVED that the Leigh Lane resident be thanked for his response and that a letter be sent to the complainants informing them of the British Horse Society's request to DCC. A copy of this letter should be sent to the Leigh Lane resident for information.

# 172.07 <u>STREET FURNITURE</u>

(Minute 106.07 refers)

Two quotations for the maintenance work to the Council's street furniture had been received. Three quotations for a replacement notice board at Leigh Lane had been received.

RESOLVED that the lowest quotation of £350.00 be accepted for the maintenance work to the street furniture, however, further investigations should be made on the replacement notice board to allow a local craftsman to tender a quotation.

## 173.07 FLOOD WARDEN SCHEME

The Environment Agency had identified that Colehill would benefit from having a Flood Warden Scheme.

RESOLVED that the Chairman of Council investigate whether it was necessary for Colehill to have a Flood Warden Scheme and report back to the next meeting of Highways and Plans Committee.

## 174.07 HIGHWAY MATTERS RAISED BY MEMBERS

- (a) DCC to be informed of the branches overhanging the highway in Colehill Lane, 100 yards before the Barley Mow Public House.
- (b) DCC to be informed that the vegetation on the land adjacent to the pharmacy in Middlehill Road is overhanging the pavement again.
- (c) Cllr Bartlett reported that weeds growing in the gulleys and on the pavements had still not been dealt with by DCC. The Clerk to write to DCC complaining about the delay and to express the Council's dissatisfaction at grass cuttings being left on the verge after being cut.
