163.18 DECLARATIONS OF INTEREST

There were no declarations of interest.

164.18 BATTLE'S OVER – 100 YEARS OF REMEMBRANCE

Cllr Urquhart advised Members of the further information she had received from the Clerk and Registrar of WCJMC regarding the Battle's Over event. Cllr Urquhart explained that Wimborne Minster Town Council would pay for the Brazier (£1,000) and she hoped that Colehill PC would agree to pay for the lighting and the printing (£700). This would mean that each council could take ownership of their purchases. If Council agreed to the expenditure then the lighting would be added to the Council's asset register and stored at the Cemetery.

Cllr Urquhart further advised that the event was a joint venture between the three Councils, it would be led by the Town Mayor and the two Parish Chairmen. The communities of Colehill, Pamphill & Shapwick and Wimborne would be invited to attend.

RESOLVED that the Council would contribute £700 for the lighting and printing. 10:0 (1 abstention)

165.18 ST MICHAEL'S CHURCH REMEMBRANCE EVENT

Cllr Urquhart advised Members of the further information she had received from the Vicar at St Michael's Church regarding the projects leading up to Remembrance Day. Cllr Urquhart explained that the Vicar would like residents to share their stories from WW1 and WW2. The stories could be about what life was like in Colehill during that time, or stories about relatives who lived in Colehill or who fought in either of the wars.

RESOLVED that Cllr Urquhart would ask the Vicar to provide some words that could be used to publicise the activity on the notice boards, Facebook, Twitter and the website.
