Students from St Michael's Middle School to be asked to place **lamplights of peace** at the War Memorial during the day of 8th May 2025. Colehill Parish Council to provide the lamps. Further detail to be agreed with Mr Ayling.

Lighting of lamplights of peace: At 9:30 pm on 8th May 2025, 8 students from St Michael's Middle School to be asked to light lamplights of peace alongside members of the Parish Council at the War Memorial. Further detail to be agreed with Mr Ayling.

Musical rendition and reading of the VE tribute at the War Memorial (tba)

232.24 ANNUAL PROJECT PLAN

The annual plan of projects which has now been documented was reviewed and ADOPTED.

233.24 PRECEPT 2025/26

Dorset Council had advised that the Tax Base for 2025/26 was 3043.

The Members considered the income and expenditure for 2023/24, the estimated balances for 2024/25, the budget for 2024/25 and the earmarked reserves for 2024/25.

Cllr Gibson proposed a Parish Council Tax Levy of £138,500.00, seconded by Cllr Davison. With a budget of £217,675.43 and a predicted income of £189,262.87, this would mean that £28,412.56 would need to be drawn down from reserves.

RESOLVED that:

- (a) the budget for 2025/26 of £217,675.43 and the earmarked reserves be approved.
- (b) a precept of £138,500.00 be levied on Dorset Council. This gave an equivalent Parish Council Tax Levy of £45.51, a 7.56% increase on that for 2024/25 (£42.31);

236.24 20MPH SPEED REDUCTION PROPOSAL

The results of the public consultation were reviewed and it was RESOLVED to respond to Dorset Council that we do not support this proposal as our public consultation evidenced that residents are not in support. The Clerk will forward to Dorset Council the summary sheet of resident's feedback.

It was RESOLVED to invite the solicitors acting for the executor of the property at Cutlers Place to approach Dorset Council's tree officer for a

recommendation on cutting back which must then come back to us for review. It will also be made clear that all costs must be borne by the estate/executors.
