77.25 CHAIR'S REMARKS

Cllrs Johnson and Davison have attended a Dorset Council Local Plan event on 14th July. This included a change to the housing targets – an 80ish % increase. There is a lot of social housing in a bad state, new development not selling across the county. Greenbelt featured highly and 10% of the greenbelt is the area with the largest amount of change in this plan. Lack of infrastructure was raised and a communities needs including schools, Doctors and employment. There was a lack of vision and how Dorset is very rural and how a local plan reflects that and amongst attendees disbelief at how this housing stock would fit. New public consultations will start around 18th August. Deadline for the plans submission is end of 2026 with implementation in 2027. If your area does not meet its housing target – there will be a presumption that planning is agreed on application.

The Clerk will add details of this and the public engagement/consultation to the website.

Cllr Davison has been for a meeting at the Colehill Cricket Club. They have a flagpole which they have said we can use. They have asked if the Parish Council could help them establish a Colehill junior league.
