221.25 DORSET COUNCILLOR REPORT

No Dorset Councillor was in attendance.

222.25 TOWN COUNCIL CONVERSION

Work and research carried out by the Town Conversion Working Group as well as the results and data from the public consultation which ran between 12th-26th November 2025 were examined. Cllr Cowsill expressed concern that the public consultation should have been published more widely – Cllr Gibson pointed out that 'clicks' on the consultation page on the website were in the region of 1,300-1,400 so that should show residents were aware although Cllr Cowsill remained concerned. RESOLVED that Colehill parish shall have the status of a town, and the council of the parish will be called Colehill Town Council, as permitted by the Local Government Act 1972 sect. 245 para 6. It was NOTED that the budget will be largely unaffected and that items needing rebranding will be done so on an 'as and when' basis rather than all in one go to save unnecessary expense.

It was further RESOLVED that the titles of Chair and Vice-Chair be retained, and we do not adopt the alternate style of Town Mayor and Deputy Town Mayor.

P/PPRD//2025/06939	<p>Location: 6 Cobbs Road, Colehill, Dorset, BH21 2RL</p> <p>Proposal: Demolition of a dangerous structure.</p> <p>OBJECTION on the following grounds:</p> <p>The Heritage Statement provided contains substantial errors of fact and unsound inferences.</p> <p>The statement in section 2.1 that “The property occupies a plot on the east side of Cobbs Road” is not true – it is to the west of Cobbs Road and hence within the Green Belt, which fact is not mentioned anywhere in the Heritage Statement.</p> <p>The dwelling at 6 Cobbs Road is actually in the Burts Hill/Merrifield/Colehill Conservation Area. The designation of this conservation area was approved on 6th September 2006. Throughout the Heritage Statement, 6 Cobbs Road is described erroneously as being within a Wimborne Minster Conservation Area. This makes a number of subsidiary observations in the Statement false or irrelevant and paints an erroneous picture of the conservation area to which Cobbs Road actually belongs, and therefore the Statement cannot be used as a reliable history and record of the building.</p> <p>Regarding the proposal to demolish, it is of interest that section 6.1 contains: “A Structural survey was undertaken post collapse, if [sic] which failed to mention any structural concerns. Since collapse another structural survey has been instructed.” The statements in section 6.2 “The building’s condition precludes safe occupation or repair, and the only viable option is controlled demolition to remove the hazard and allow for future redevelopment” and in section 6.3 “The extent of structural failure and loss of original fabric means that the building cannot be repaired or restored without complete reconstruction” would therefore still seem to be questionable.</p> <p>Section 7.3 contains a statement that the National Trust’s agreement to demolition is documented as</p>

	<p>part of the planning application. But this agreement has not been evidenced.</p> <p>We also comment that as of 8th December 2025 at 10:30 no Site Notice has been displayed.</p>
P/HOU/2025/06798	<p>Location: 4 Stroud Close Colehill BH21 2NX</p> <p>Proposal: Replace existing roof tiles, form new WC window and change height of front window, change direction of external staircase, form lean to roof to rear elevation and change external cladding</p> <p>No comment</p>

226.25 BUDGET AND PRECEPT 2026/27

Dorset Council had advised that the Tax Base for 2026/27 was 3052.5.

The Members considered the receipts and payments for 2024/25, the estimated balances for 2025/26, the budget for 2025/26 and the earmarked reserves for 2025/26.

Cllr Bridle proposed a Parish Council Tax Levy of £143,000.00 seconded by Cllr Cowsill. With a budget of £214,549.27 and a predicted income of £188,696.40, this would mean that £19,852.87 would need to be drawn down from reserves.

RESOLVED that:

- (a) the budget for 2026/27 of £214,549.27 and the earmarked reserves be approved.
- (b) a precept of £143,000.00 be levied on Dorset Council. This gave an equivalent Parish Council Tax Levy of £46.85, a 2.9% increase on that for 2025/26 (£45.51);

It was RESOLVED to appoint Contractor A to carry out works recommended in the Dorset Council tree team inspection report to trees in both Triangle Woods and Churchmoor Copse.

It was RESOLVED to go out for quotes to suppliers for proposed exercise equipment for a potential installation at Olivers Park.
