*Members will remember that the bench at Leigh Road (Bytheway) needs to be repaired due to one slat being broken. Dorset Works Organisation has inspected the bench and a repair cannot be carried out on site as the fixings are rusted. DWO has asked how far the Council wishes to go with the refurbishment as most of the timbers are in poor condition, as is the paintwork. DWO says that a new bench would work out cheaper than a refurbishment. The cost of the bench recently installed at Wimborne Road West was £375 (not including VAT, fixings and delivery).

To decide whether the bench should be replaced, refurbished or removed. If it is decided to replace the bench then Members might wish to consider a new location or defer replacing the bench until after the proposed development at Leigh Road has been built.
