PLANNING DECISIONS - *The following applications have been APPROVED by DC:*

P/HOU/2024/02526 - 16 Colborne Avenue, Colehill, Dorset, BH21 2PZ - Demolition of existing conservatory, garage and store and erection of single storey extension to provide a new garage and living room together with associated internal alterations.

DRAINAGE SCHEMES - The following capital drainage schemes have been programmed to take place in the coming months in this Parish:

Hayes Lane outside 43 – 49, Colehill – adjust kerb line and footway, install two new carriageway gullies, install new footway aco drainage – to resolve property flooding and infiltration of foul sewerage system

Leigh Road nr entrance to Quarter Jack Park, Colehill – realign highway surface water sewer – highway drainage system is partially blocked/damaged

8. Oliver’s Park/Churchmoor Copse Delegated spending

To note the spending of £760 on grounds maintenance in Oliver’s Park/Churchmoor Copse under delegated powers. This work included cutting back all paths, behind the goal mouths and around the Scout hut, large area of bamboo cut back with arisings removal and re-clearing of small glades.
