PA NODEVELOPMENT PROPOSED3/20/0857/FULLand between 4 & 10 Sunnybank Way

Erect pair of semi-detached chalet bungalows, with dormer windows to front and rear.

OBJECTION – on the grounds of overdevelopment and would suggest the original single is more suitable.

The site is also inadequate to support this particularly in terms of not enough car parking and we would refer you to your Dorset Council parking calculator & guidance <u>http://bit.ly/3me8Clj</u>

GOVERNMENT WHITE PAPER

563.20 Cllr Gibson feels this is too complicated to try to formulate a corporate response. Cllr Davison said she would circulate the draft response from the East Dorset Environment Partnership. Cllr Gibson gave an overview to the DAPTC planning training and that the trainers opinion is that the White paper is likely to go through without much consideration to comments, and that Parish and Town Council may well need to look at their own planning committees and perhaps trying to have more influence at the start of development as commenting at the end may be something which would largely not be required any more.

564.20 BENCHES

Members NOTED that the benches have all now been repainted. The bench down at Cranborne Road/Furzehill has slats on the seat which were too rotten to paint, so they will need to be replaced before they can be repainted. The back slats and the frame has been done.

565.20 PLAY AREA/ST MICHAELS DIRT
