It was RESOLVED to appoint Cllr Michael Gibbs as Chair of this committee for the ensuing year.

50.24 APPOINTMENT OF VICE-CHAIR OF COMMITTEE

It was RESOLVED to appoint Cllr Clare Davison as Vice-Chair of this committee for the ensuing year.

52.24 MINUTES

54.24 ALDI DEVELOPMENT

It was RESOLVED to object and to agree with the many members of the public who attended the meeting and made representations that the site is the wrong location due to the current ongoing highway issues. The roundabout is the busiest in Dorset and one of the busiest in the south coast. The bulk of the site is in Greenbelt and this should form part of the objection. Traffic assessment would likely show this is not likely to work. Noise and light pollution are factors that should be examined and exhaust fumes will be increased due to the anticipated time each vehicle will have to wait to pull in and out of the proposed entrance/exit.

55.24 HAYES LANE HIGHWAYS ISSUES

It was RESOLVED that Cllr Urquhart produces a bullet point list of issues in Hayes Lane which will be submitted to the accident reduction team and Highways in support of the residents alongside their residents report.

56.24 FAIRTRADE ROADSIGNS

It was RESOLVED to make a donation of £1,000 to the Fairtrade organisation for the erection of Fairtrade signs on the Welcome to Colehill signs which come in from roads which do not already have one (roads coming in from Wimborne already are covered as the Wimborne signs already have the Fairtrade signs attached).
