622.20 PURCHASE OF TREES

Member noted that following the resolution at the Council meeting of March 10th (but implementation delayed due to Covid) a total of 630 saplings have been ordered to give out to residents on a first come first served basis, one tree per household. A Parish Council has a duty to conserve biodiversity under the Natural Environment and Rural Communities Act 2006 so this spending falls under the Local Government Act 1972 s 111 – power to spend which is coincidental to the discharge of the Council's functions. Advice has been taken from Dorset Council's tree officer on what to do with any excess trees not collected. Upon delivery which is anticipated on Thursday this week, advertising will go out and a 'collection station' will be set up which will need to be manned across the weekend.

Cllr Cunningham appeared to leave the meeting at 7:54pm. He did not vote during the time his computer appeared to be logged into the meeting.
