221.19 LITTER BIN AT ONE STOP

Members looked at the photograph taken by Cllr Gibson and discussed the installation of a bin. The new style wheelie bin is the only option as DWP will not take on any new agreements to empty older style bins. The costings were looked at. Cllr Johnson said the wheelie style bin is incredibly ugly and would be the only one in the village like it. Cllr Morawiec said that he visited the area at school finishing time and that all the school children were over the other side of the road and that actually nobody was littering. Cllr Bridle said that these wheelie bins do get vandalised and burn easily. It was proposed and seconded not to put a wheelie bin in the area. Unanimous.

222.19 PUBLIC BENCHES

Members NOTED there were no faults to report. The bench on Wimborne Road West has some building material and mounds of soil nearby. Cllr Dover will investigate why this has been left there.

223.19 WAR MEMORIAL/BUS SHELTER

Members NOTED there were no faults to report. The Clerk reported that the bus shelters could do with being cleaned, either now or in the spring. RESOLVED that the Clerk would investigate the cost of cleaning both the bus shelters.

224.19 PLAY AREA/ST MICHAEL'S DIRT

Members NOTED there were no faults to report. Cllr Johnson talked about the lack of responsibility being taken for the dog waste bins. Cllr Dover said she would look into it.

225.19 SPEED INDICATOR DEVICE

Members NOTED that the Speed Indicator Device was located at Middlehill Road and the most recent results were discussed. Cllr Gibson had put the results into a graph which was really easy to read and very useful and he will share this with all the members. Cllr Johnson talked about the analysis data carried out by Dorset Council and that there is just not enough speeding the warrant an extra SID post, even though public perception is that it's much higher/worse than the data shows. There has only been one fatality in Colehill on the roads and this was not due to speeding. Cllr Urquhart informed members that she and the Clerk had been asked to meet with the MP Michael Tomlinson on Friday and that Cllr Gibson's info charts would be useful for that meeting.

226.19 GRIT BINS

Members NOTED there were no faults to report. It was NOTED that Cllr Gale was re-spraying the lids and was two thirds of the way through all the bins.

- (b) Cllr Mitchell said he has confronted a lady dumping garden waste on Rowlands Hill. He had explained the consequences of this, and she had put the debris back in her vehicle.
- (c) Cllr Johnson said there is also dumping going on in Cannon Hill Woods. Cllr Mitchell said he would write to Marilyn Barber and ask for it to be mentioned in the Viewpoint and 4Dorset.
