## Chairman's Report to 2015 AGM:

#### **Our Recent Achievements:**

- 1. 'Update' newsletters published and distributed quarterly.
- 2. Participated in local PACT Panels.
- 3. Participated in Police/Councillor public engagement events in Wimborne & Colehill.
- 4. Contributed £250 towards security to the Reef Youth Centre.
- 5. Offered opportunity for local groups to apply for project funding.
- 6. Provided copy of National NHWN/ADW Stay Safe booklet to each of members.
- 7. Provided copies of National NHWN/ADW Stay Safe booklet to our libraries.

#### **ADW Recent Achievements:**

Ran meetings for members to listen to and question guest speakers Deputy Chief Constable (DCC), and Police & Crime Commissioner (PCC).

Improved partnership working in some areas represented at Police/Watch Plan meetings.

Obtained funding from PCC to enable provision of tools and materials for use by Watch Groups.

Managed provision of Community Speed Watch kits.

Held meetings with DCC.

Commissioned project with Bournemouth University to propose ways in which Home

and Neighbourhood Watch could increase membership and coverage.

Received briefing and ceremony from Police on output from strategic review of Neighbourhood policing. Involved in Rotary Police awards judging.

#### **Our Current Year Focus Areas:**

- 2. Working with Safer Neighbourhood Team (SNT) to recruit new Contacts, Committee Members and Helpers.
- 3. Using demo kit and Sheducation to provide crime prevention advice and products for sale.

- 2. Implementing selected Bournemouth University project recommendations.
- 3. Improving Watch scheme coverage in under represented areas.
- 4. In partnership with Dorset Police, convincing Neighbourhood Inspectors and Sergeants of the value of Watch Groups.
- 5. Cyber Crime awareness and prevention.
- 6. Volunteer recruitment.
- 7. Providing Stay Safe booklets for recruitment and reassurance.
- 8. Encouraging Co-ordinators, Contacts and Members to register on Dorset Alert messaging system.
- 9. Making available for loan to Watch groups, pull-up banners and posters together with hand-outs plus necessary equipment to enable them to conduct their own crime prevention activities.

# Policing Update & Priorities plus Q&A

A very interesting and informative talk was given by Inspector Wayne Nock, although crime has decreased the cost of crime has increased. Cyber crime has increased and is very concerning.

Following the talk we were introduced to items of police equipment by Inspector Nock and Sgt Travers, who demonstrated and circulated the items and uniforms currently in use. It was interesting and instructive to compare the newer uniforms etc. with previous versions.
